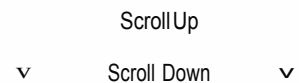

NRS 293.780 Voting more than once at the same election. A person who is entitled to vote shall not vote or attempt to vote more than once at the same election. Any person who votes or attempts to vote twice at the same election is guilty of a Category D felony and shall be punished as provided in NRS 193.130.

EARLY VOTING SCHEDULE

Vote early at the Storey County Clerk's Office on "B" Street at the Courthouse, second floor, in Virginia City, Nevada, starting Saturday, Saturday May 26, 2018, through Friday, June 8, 2018.

If you would like to request an absent ballot, you must submit your request in writing to the Clerk's Office no later than Tuesday, June 5, 2018.
